Exhibitor Guidelines

SET UP TIMES

The Anderson Building, located on the Lyon County Fairgrounds, will be open for set up the day before the show (Friday, February 23, 2018) from 8:00 a.m. to 6:00 p.m. or the day of the show (Saturday, February 24, 2018) from 7:00 a.m. to 8:30 a.m.

PROTECTION OF THE FLOOR

Please use some form of tire pad (carpet, cardboard, mat, etc.) under all/any tire(s). Any display that could possibly leak fluid also needs a floor protector completely underneath it. All tires or wheels must be clean.

Please use either tarp or thick plastic underneath any or all landscape blocks (including cinder blocks) and mulch that may be used in the booth display.

All articles/equipment/display items must be brought into the building on carts or dollies. Dragging items across the floors is prohibited.

Equipment that has wheels or is self-propelled may be driven or rolled across the floors without the use of a cart or dolly.

SET UP RESTRICTIONS

Hanging of signs and/or banners from the walls and ceiling is prohibited. A grid-wall section will be provided to each booth for any signs and/or banners that need to be hung. No booth may exceed 8 feet in height.

NO SMOKING POLICY

Anderson Building has a NO SMOKING POLCY. We would appreciate you help in seeing that cigarette butts are place in the proper receptacles located at the entrance of the building.

VENDOR BOOTH TAKE-DOWN

Tear down begins at 4:00 p.m. on Sunday, February 25, 2018. Please do not begin take-down prior to 4:00 p.m. The Anderson Building will also be open on Monday, February 26, 2018 for removal of any additional booth items that were not removed on Sunday.
